Product Obsolescence Information:

Cypress announces the obsolescence of select products from its automotive PSoC® 4100 and PSoC® 4200 device family's portfolio. A bi-annual review of the Cypress product portfolio results in the business decision to discontinue certain product offerings. The attached listing contains products that will be replaced by a functional, drop-in replacement. A drop-in replacement is defined as a product that is pin-to-pin and function/feature compatible with the product that will be obsoleted.

Last Time Buy (LTB) and Last Time Ship (LTS) dates are also provided for each product. The LTB date denotes the last day on which orders will be accepted; these orders maybe scheduled for shipment through the LTS date provided.
