

DESCRIPTION/ORDERING INFORMATION

The SN74LVC00A-Q1 quadruple 2-input positive-NAND gate is designed for 2.7-V to 3.6-V V_{CC} operation.

The device performs the Boolean function $Y = \overline{A \cdot B}$ or $Y = \overline{A} + \overline{B}$ in positive logic.

Inputs can be driven from either 3.3-V or 5-V devices. This feature allows the use of this device as a translator in a mixed 3.3-V/5-V system environment.


LOGIC DIAGRAM, EACH GATE (POSITIVE LOGIC)





- (6) Lead finish/Ball material Orderable Devices may have multiple material finish options. Finish options are separated by a vertical ruled line. Lead finish/Ball material values may wrap to two lines if the finish value exceeds the maximum column width.
